

Memorandum of Understanding

This Memorandum of Understanding ("MOU") is signed on the day of 2/8/23 BY AND BETWEEN:

GOVERNMENT POLYTECHNIC, JALGAON

(A government institute which runs various diploma courses which are affiliated to MSBTE; hereinafter referred to as "GPJ")

AND

TASHVITA WORKS ELECTRICAL

PLOT NO. P-68, MIDC AREA, GODAVARI ENGLISH ROAD, JALGAON, 425004

This Memorandum of Understanding is proposed to bridge the gap between academia and industries. The MOU aims at skills development by providing various training to the students and faculty members of Government Polytechnic, Jalgaon.

Through this Memorandum of understanding, the two parties agree to the following:

- a) A **steering committee** will be set up to monitor the activities of the MOU. The committee will consist of Dr. P. M. Patil (Principal, Govt. Poly. Jalgaon) and Mutual consent, the steering committee can be expanded to include more members from the two institutions. The steering committee will be the supreme body as far as the implementation of the activities of the MOU, the continuation of MOU, termination of the MOU are concerned.
- b) **GPJ** and **TASHVITA WORKS ELECTRICAL** will jointly conduct short term training programs in the following areas.
 - i. **Soft skills:** These include-confidence building programs, communication & presentation skills, leadership development, professional etiquettes, workshops on personality development, time management, group discussion, interview techniques, technical reporting, etc.
 - ii. **Stress Management:** These include-personality and stress management, human behavior, relaxation techniques, job performance, job satisfaction, corporate culture, stress and health, stress and lifestyle diseases, etc.
 - iii. **Entrepreneurship Awareness workshop.**
 - iv. Any other training areas, as may be defined fit for both the parties.
- c) **GPJ** will organize training programs for its students and faculties, on the above mentioned areas [b(i) to b(iv)] and If possible, **TASHVITA WORKS ELECTRICAL** will conduct / coordinate these trainings .
- d) **GPJ** will provide all necessary infrastructure such as – training hall, projector, PA system, Computer lab, etc. which will be required for such training from time to time.
- e) If possible, **TASHVITA WORKS ELECTRICAL** will provide all necessary training material as applicable, which will be mentioned in the training proposals submitted with **GPJ** from time to time.

- f) Batch size, payment terms, award of certification and all other relevant details will be as per training proposals of **TASHVITA WORKS ELECTRICAL** submitted with **GPJ** from time to time.
- g) Course dates and timings will be decided on the mutual convenience of both the parties.
- h) **Expert lectures / Workshops /Events:** If **GPJ** wishes to organize lecture series / national events. If possible, **TASHVITA WORKS ELECTRICAL** will assist **GPJ** in providing speakers.
- i) **Industrial Visits:** If Possible, **TASHVITA WORKS ELECTRICAL** will assist **GPJ** in arranging industrial visits of its final year students.
- j) **Validity:** This MOU is valid for a term of three year from the date of signing, unless terminated earlier or extended by mutual agreement of both the parties at least thirty days prior to the expiry.
- k) **Miscellaneous:**
- All the condition, changes, erasures, amendments, waivers, etc. shall only be in writing, duly executed by both the parties.
 - This MOU and any amendment thereof are limited to the purpose of MOU only.
 - This MOU sets from the entire agreement and understanding between the parties with respect to the subject matter hereof and merges all discussions and negotiations between them prior to such execution.
 - This MOU shall be governed by the laws of Republic of India.
