The accreditation status awarded to the program as indicated in the above table does not imply that the accreditation has been granted to **Government Polytechnic, Jalgaon, NH-06, Jilha Peth, Opposite to Government ITI, Jalgaon- 425001, Maharashtra** as a whole.
